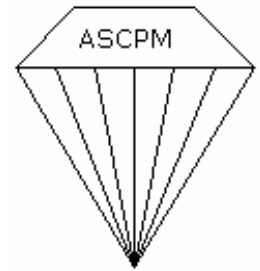

### 2004 Accomplishments:

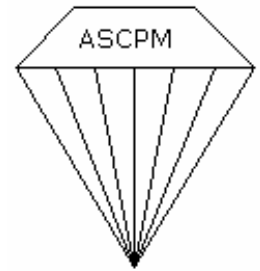
- The Society provided networking opportunities for its members at four quarterly "Lunch and Learn" meetings. Speakers provided information of interest to state and local government managers.
